- 2. There were no declarations of interest.
- 3. There was **no public participation** regarding matters on the agenda.
- 4. Minutes of Previous Meetings
 - 4.1. Council approved the minutes of the Meeting of Council held on 11th November 2025.

5. HR Committee Report

- 5.1. Council received a report from the Chair of the Human Resources Committee
- 5.2. **Council approved** a progress report on the actions arising from the new requirements for Data and Digital Management, and the actions to be taken.

8.1. Council deferred the nomination of additional trustees to the Batheaston Sports Foundation as none had been received.

WORKING GROUPS

9. Highways Transport and Planning Working Group

- 9.1. Council received a verbal report from Cllr McCarthy.
 - 9.1.1. The event to celebrate the switching on of the Christmas Lights had taken place on Thursday 4th December. It had been moved from the previous Friday at short notice, and this reduced numbers. Councillors agreed that the first weekend of Advent is far preferred.
 - 9.1.2. They commented on how the new lights make the effect even better.
 - 9.1.3. Cllr McCarthy commented that she and the Clerk are progressing the refurbishment of the noticeboards.
 - 9.1.4. Streetlights: there has been a lot of activity, as referenced in the Complaint below. In addition, Cllr McCarthy has asked B&NES to consider the installation of an additional light on School Lane.
 - 9.1.5. Councillors commented on what a great job the Cotswold Voluntary Wardens had done of clearing bramble on Bannerdown Common.
