

**Minutes of a Meeting of Batheaston Parish Council
held at 7:15pm on Tuesday 13th January 2026
at the Rhymes Pavilion**

PROCEDURAL MATTERS

- 1. Council accepted** apologies for absence from Cllrs Butt, Gray, Skelton and Squire
- 2. There were no declarations of interest.**
- 3. There was no public participation** regarding matters on the agenda.
- 4. Minutes of Previous Meetings**
 - 4.1. Council approved** the minutes of the Meeting of Council held on 9th December 2025.

GOVERNANCE MATTERS

- 5. Budget and Precept for 2026/27**
 - 5.1. Council received a report from the Clerk outlining the current position and forecast for the end of the 2025/26 financial year.
 - 5.1.1. He summarised that the current expectation is that the Council will accrue a surplus of £21,000 for the year, although this is dependent on Council decisions regarding discretionary items in the remaining months of the year.
- 6. Council received the Clerk's projection of operational income and expenditure for 2026/27, and the options for setting the Precept.**
 - 6.1. He set out the structure of the presentation of the budget, including assumptions about discretionary items.
 - 6.2. Councillors discussed the need to limit householder rises to inflation, currently running at 3.8%.
- 7. Council approved the outline budget and a Precept of £141,100 for 2026/27.**
 - 7.1. The Clerk will submit the form to B&NES.

WORKING GROUPS

8. Highways Transport and Planning Working Group

- 8.1. Council received a verbal report from Cllr McCarthy.
 - 8.1.1. She highlighted that Council has received more complaints about parking, including on pavements, blocking pedestrians, on Northend. Cllr McCarthy will follow up with the residents who have lodged concerns.

- 8.1.2. Cllr McCarthy also reported that she and the Clerk had met B&NES Cllr Warren and officers to view pinch points on Catherine Way, where badly parked vehicles obstruct buses on occasions. B&NES Officers are aiming to propose changes to restrictions.
- 8.1.3. Finally she noted that agreement had been reached regarding extending parking restrictions by one car length on Northend (near to School Lane). B&NES will propose this for public consultation in due course.
- 8.2. **Council resolved** to allocate up to £2,000 to clear vegetation and to repair the Parish Council's streetlight on West View Road.

- 8.3. **Council noted** that work has been commissioned to repair the Parish Council's streetlight on Victoria Gardens at a cost of £310, and that the Council are seeking the advice of B&NES Officers regarding the request for an additional light.

9. Nature and Environment Working Group

- 9.1. **Council received** a verbal report from Cllr Lewis.
 - 9.1.1. He noted that the work to prune the Mulberry tree, with the objective of saving it after last year's damage, had been approved by B&NES, and is due to happen the following Friday, 16th.
 - 9.1.2. The Clerk is preparing a Planning Application for the stone masonry repairs to the wall of the Secret Garden (some of which is listed).
 - 9.1.3. Contactless payment has been added to the toilet door mechanism, and the door repaired.
- 9.2. **Council approved** a proposal to develop a plan to create a Woodland Walk along St Cathrines Brook, in collaboration with Grow Batheaston.
- 9.3. **Council noted** the workshop on 3rd February, part of the Energy in your Community project seeking to establish renewable energy resources in the area.
- 9.4. **Council approved** £7,000 to conduct recommended tree surgery



9.5. **Council noted** that the Clerk is in the process of submitting a planning application for the stone masonry in the Secret Garden.

15.1.1. He reported that the main item would be critical emergency response. Councillors suggested that there might also be a presentation on Batheaston Sports Foundation.


16. Chair's Report
